## June 3 - 2113 Hours

A Hit & Run accident was reported on Wilmington-Dayton Road. The victim reported that while traveling on Wilmington-Dayton Road, a vehicle driving in the opposite direction crossed the double yellow line, traveling into his lane of traffic, and striking the victim's vehicle. The suspect vehicle did not stop, and continued to drive away. A search for the suspect vehicle was unsuccessful.

#### June 3 - 2223 Hours

A routine registration check on a vehicle in the lot of a State Route 725 business revealed that the vehicle owner was suspended.
