June 28 - 1351 hours

Officers were dispatched to an address on North East Street on a domestic dispute. Further investigation revealed that the dispute was verbal in nature only.

June 28 - 1826 hours

An officer stopped a vehicle for an equipment violation. Further investigation and a consent to search the vehicle led to drug paraphernalia being recovered. The subject was charged with various drug related charges.
