August 16, 2015 - 0207 hours

Bellbrook Sergeant stopped a vehicle on Wilmington-Dayton Rd for a moving violation. During the stop, the driver refused to talk to the officer and drove away without identifying herself. The officer followed her until she left the City. Information was relayed to surrounding agencies. Not long after, Kettering Police, and the Ohio State Highway Patrol were in pursuit of the vehicle, with the final stop of the vehicle taking place in Beavercreek. The driver, a 30-year old female from Bellbrook, was arrested by Beavercreek Police Department. Criminal charges were filed by several agencies involved. Bellbrook Police Department charged the suspect with Reckless Operation of a Vehicle, and Obstruction of Official Business. The female remains in the Greene County Jail awaiting her Court proceeding.

August 16, 2015 – 1822 hours

A routine vehicle registration check, revealed that the driver of the vehicle was suspended. The officer stopped the vehicle on Washington Mill Rd. The driver was cited into Court for Driving under Suspension.

August 17, 2015 - 0036 hours

An officer was dispatched to Justin Ct, on a welfare check. Female was unable to make contact with her husband. Officer made contact with the husband, and no problem was reported.

August 17, 2015 – 0139 hours

Information was received from Kettering Police Department, in reference to an intoxicating subject possibly driving to an address on West Maple Street. A Bellbrook officer spotted the vehicle, and stopped it. The driver of the vehicle refused a sobriety test, and the suspect was taken into custody for OVI. The driver was released to a relative.

A vehicle stopped to turn left onto Moss Oak Trail from Wilmington-Dayton Road, resulted in a four-car crash, after the fourth vehicle was unable to stop in time, pushing the third and second vehicle into the stopped car.
