## April 3, 2016 - 0244 hours

An officer stopped a vehicle on Wilmington-Dayton Road for a moving violation. A homemade machete was found in the vehicle. The item was seized from the 28-year old male from Dayton. The suspect was cited into Xenia Municipal Court for Carrying Concealed Weapon and Speed.

#### April 4, 2016 - 1526 hours

Officers were dispatched to Mill Pond Drive on the report of a suspicious vehicle. Contact was made with the driver who advised she was tired and getting some sleep before driving home from work.

He was cited into Xenia Municipal Court for Driving under Suspension.
