May 1, 2016 - 1029 hours

Officers were dispatched to Upper Bellbrook Road on a burglary alarm activation. Upon the officers' arrival the homeowner advised she had accidentally set off the alarm.

May 1, 2016 - 1501 hours

A domestic dispute was reported on Possum Run Road. Investigation led to the arrest of a 14-year old juvenile for Domestic Violence. The juvenile was transported to the Greene County Juvenile Detention Center.

May 1, 2016 – 1519 hours

Officers were dispatched to South Linda Drive on the report of a domestic dispute in progress. Investigation led to the arrest of a 25-year old male for Domestic Violence and Assault. The suspect was transported to the Greene County Jail.

May 1, 2016 – 1622 hours

Officers were dispatched to Crescent Court on the report of a missing elderly female. While the officers were gathering information from the complainant, a nearby neighbor had located the female and brought her home.

May 1, 2016 - 1800 hours

A hit-skip accident was reported on Plantation Trail. An unknown vehicle had struck a street sign and traveled through a yard. Report taken.

May 2, 2016 – 0622 hours

Officers were requested to assist Sugarcreek Township Police Department with a low hanging tree that was causing a traffic hazard on Little Sugarcreek Road. The officers stood by for traffic control until the Sugarcreek Township Service Department arrived to remove the tree.



May 2, 2016 - 1728 hours

An officer stopped a vehicle on Upper Bellbrook Road due to having knowledge that the driver did not have a valid driver's license. The 64-year old male driver from Spring Valley was cited into Xenia Municipal Court for Driving under Suspension.

May 3, 2016 – 1035 hours

Officers were dispatched to Bellemeade Drive on the report of a burglary alarm activation. Upon the officers' arrival the homeowner advised that her alarm system went off unexpectedly while in her home. The residence checked ok. Confirmed false alarm.

May 3, 2016 - 1347 hours

An officer was dispatched to a business on East Franklin Street for a natural gas leak. The Bellbrook Fire Department, Road Department and officer provided assistance until the utility company advised it was safe for all personnel to clear the scene.

May 3, 2016 - 1803 hours

A barking dog was reported on East Franklin Street. Upon arrival, the officer located the animal and made contact with the owner. The owner was advised about the complaint and given a verbal warning.

May 4, 2016 – 0919 hours

An officer assisted the Bellbrook Fire Department with a vehicle leaking fuel onto the roadway on Upper Hillside Drive. Contact was made with the vehicle owner who was ordered to remove the vehicle from the roadway immediately. The officer remained on scene until no longer needed by the Bellbrook Fire Department.



May 4, 2016 - 1726 hours

A domestic dispute in progress was reported on West Maple Street. Investigation led to the arrest of a 17-year old male for Domestic Violence by Threats. The suspect was transported to the Greene County Juvenile Detention Center.

May 4, 2016 – 1736 hours

An officer was dispatched to West Franklin Street near Vemco Drive for a disabled vehicle in the roadway. The officer stood by to provide traffic control until the vehicle was removed by a tow company.

May 5, 2016 – 0300 hours

An officer stopped a vehicle on West Franklin Street for a moving violation. Investigation revealed that the 21-year old driver from Bellbrook was impaired. The suspect was cited into Xenia Municipal Court for Operating a Vehicle while Intoxicated and Failure to Signal.

May 5, 2016 - 1015 hours

A traffic accident with injuries was reported on West Franklin Street. A vehicle traveling Eastbound on West Franklin Street ran a red light and struck another vehicle. The driver-at-fault, a 38-year old male from Kettering was cited into Xenia Municipal Court for Failure to Obey a Traffic Control Device. The victim was found to not have a valid driver's license. She was cited into Xenia Municipal Court for Driving under Suspension.

May 6, 2016 – 0037 hours

While on patrol an officer located a vehicle at the park on Vemco Drive. The officer made contact with the occupants and advised them the park was closed after dark. The subject left the area without any problems.



May 6, 2016 - 0204 hours

An officer stopped a vehicle on West Franklin Street for an equipment violation. Investigation revealed that the 43-year old driver from Bellbrook was impaired. The suspect was cited into Xenia Municipal Court for Operating a Vehicle while Intoxicated and Failure to Dim Headlights.

May 6, 2016 – 0729 hours

A traffic stop on South Main Street revealed that the 27-year old driver from Bellbrook did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension.
