#### June 26, 2016 – 0502 hours

While on bike patrol, an officer located an open garage door on Justin Court. Contact was made with the homeowner who verified that nothing had been taken from the garage and then secured the door.

#### June 26, 2016 - 0520 hours

An officer located an open garage door on Kensington Drive. Contact was made with the homeowner who closed the door.

#### June 26, 2016 – 0940 hours

An officer was dispatched to Ridgetop Drive on the report of a disabled vehicle in the roadway. Upon contact with the owner, it was learned that the car had a dead battery. A neighbor assisted with getting the car started. The officer stood by until the vehicle was removed from the roadway.

#### June 27, 2016 – 1107 hours

A resident on Portage Path Drive reported that an unknown subject had used her bank card at a business in Dayton for a purchase of over \$250.00. The report was assigned to a detective.

#### June 27, 2016 – 2043 hours

An officer stopped a vehicle on West Franklin Street for an equipment violation. Investigation revealed that the 31-year old driver from Xenia did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension and issued a written warning for No Front License Plate.

#### June 28, 2016 - 1747 hours

An officer was dispatched to South Lakeman Drive on a theft report. The complainant advised that someone had taken a power washer from his garage while the door had been open for several days. Neighbors had not witnessed anything.



#### June 28, 2016 - 1821 hours

An officer stopped a vehicle on East Franklin Street for an equipment violation. Investigation revealed that the 38-year old driver from Xenia was wanted on a warrant from Xenia Police Department. The subject was issued a written warning for Cracked Windshield. She was then taken into custody and turned over to a Xenia Police Officer.

#### June 28, 2016 – 2159 hours

Officers were dispatched to West Franklin Street on the report of a domestic violence incident. Investigation revealed that the dispute had been verbal in nature, between the complainant and her grandson. The complainant turned over marijuana and a drug pipe to the officers that belonged to her grandson. The 16-year old suspect was cited into Greene County Juvenile Court for Drug Abuse and Possession of Drug Paraphernalia.

#### June 28, 2016 – 2211 hours

A resident on Ryder Court reported that an unknown subject had cut her screen door. The complainant advised that no one had made entry into the home. It was unknown when the damage occurred.

#### June 28, 2016 - 2245 hours

A resident on Bellemeade Drive reported hearing a loud noise like someone was trying to get into the complainant's home. Officers checked the area and residence and found no signs of any criminal activity.

#### June 29, 2016 – 1259 hours

Officers were dispatched to a business on State Route 725 for a welfare check on an elderly male who seemed to be disoriented. Contact was made with a relative who picked up the subject and took him home.



#### June 30, 2016 - 1349 hours

Officers assisted the Sugarcreek Police Department with traffic control after an accident occurred on Wilmington-Dayton Road near Centerville Station Road.

#### June 30, 2016 – 1433 hours

An officer released a raccoon stuck in a garbage can at the Eagleland playground.

#### June 30, 2016 – 1515 hours

A business on State Route 725 reported receiving several calls from a subject claiming to work for a utilities company. The caller told the complainant to pay their \$200 outstanding bill or their utilities would be disconnected. An officer called the phone number the call had originated from and upon identifying himself to the caller the call was disconnected. Further calls would not go through. The business was not out of any money due to this scam call.

#### June 30, 2016 – 2245 hours

A dog bite was reported on Ryder Court. The victim, who is the owner of the canine was treated by Bellbrook Medics.

#### July 1, 2016 – 0218 hours

An officer stopped a vehicle on West Franklin Street near Little Sugarcreek Road for a moving and equipment violation. Investigation revealed that the 49-year old female driver from Centerville was impaired. She taken into custody and cited into Xenia Municipal Court for Operating a Vehicle while Intoxicated. She was later released to a relative.

#### July 1, 2016 – 0359 hours

A 54-year old resident threatening his 21-year old neighbor with a gun on Barnett Drive was arrested and charged with Aggravated Menacing and Using Weapons while Intoxicated.



#### July 1, 2016 - 1745 hours

A subject reported that she had accidentally left her purse with billfold at a business on State Route 725. The business reported that someone had found her billfold and that she could come pick it up. After retrieving her billfold, she noticed that 5 credit cards and her driver's license were missing from it. There was a charge made on one of her credit cards. The report was assigned to a detective.

#### July 1, 2016 - 2239 hours

Officers responded to Ryder Court on the report of Domestic Violence. Investigation led to the arrest of a 58-year old female for Domestic Violence by Threats and Menacing.

#### July 2, 2016 - 0727 hours

While on routine patrol an officer located an open car door on Woodedge Drive. Contact was made with the owner who checked the vehicle to assure that nothing was missing.

### July 2, 2016 - 1229 hours

An officer was dispatched to Bellbrook Plaza where a dog had been left in a parked vehicle. The vehicle was parked in the shade and had two open windows. The officer checked on the dog which did not show any signs of distress.

# July 2, 2016 – 1720 hours

A resident on West Franklin Street reported receiving unwanted phone calls and text messages from a known person. Contact was made with the suspect and he was ordered to cease all contact with the complainant.

## July 2, 2016 – 1820 hours

An officer was dispatched to a business on State Route 725 where someone had changed the oil in their vehicle and left the oil in a container on the sidewalk. A Bellbrook Fire Department member responded to collect the oil and properly disposed of it.



#### July 2, 2016 - 2303 hours

While on routine patrol an officer located an occupied car at Magee Park. Contact was made with the driver and she was advised that the park was closed during dark hours. She left the area without problem.

#### July 2, 2016 – 2325 hours

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation. A bag of marijuana was located inside the vehicle. The 46-year old driver from Dayton was cited into Xenia Municipal Court for Drug Abuse. Further investigation revealed that a 47-year old female passenger from Dayton was wanted on a felony warrant for drug violations from the Montgomery County Sheriff's Department. She was taken into custody and transported to the Greene County Jail to await extradition to Montgomery County Jail.
