### October 9, 2016 - 0601 hours

Officers were dispatched to a business on South Main Street on the report of an alarm activation. Investigation revealed that an employee had accidentally set off the alarm.

Officers were dispatched to Plantation Trail to assist the Bellbrook Fire Department with a possible structure fire. Officers assisted with traffic control until no longer needed.

#### October 14, 2016 – 1957 hours

A citizen reported that he had observed a male subject hide a backpack in the bushes near the football stadium on Upper Bellbrook Road. Officer searched the area and located the backpack. Inside the backpack were drugs and drug paraphernalia. A cellular phone with a photo of the owner was also located. Officers were able to identify and locate the suspect, a



17-year old male from Bellbrook. He was cited into Greene County Juvenile Court for Drug Abuse and Drug Paraphernalia.

## October 15, 2016 - 0056 hours

A dispute was reported on Ryder Court. Investigation led to the arrest of a 44-year old female for Disorderly Conduct by Public Intoxication. The suspect was transported to the Greene County Jail.
