February 26, 2017 - 0909 hours

A private property accident was reported at Bellbrook Plaza. The vehicle owners exchanged insurance information and a report was taken.

February 26, 2017 – 1622 hours

A resident on Woodedge Drive reported finding fraudulent charges on a credit card account. The bank was notified and the credit card account closed. The complainant was not held liable for the credit card charges.

February 26, 2017 – 1849 hours

Officers were dispatched to Old English Circle on report of an unwanted person. The suspect, a 39-year old male from Xenia, had left the complainant's home before the officers' arrival. The suspect was contacted and ordered to cease all contact with the complainant. The suspect was also Criminally Trespassed from the property.

February 27, 2017 - 1327 hours

An officer was dispatched to Periwinkle Drive where a female from Carlisle had locked her keys in her vehicle. The officer was able to gain entry into the vehicle.

February 27, 2017 – 1357 hours

An unruly juvenile was reported on South East Street. Investigation revealed that the 16-year old male from Xenia had violated his probation. The suspect was taken into custody and transported to the Greene County Juvenile Detention Center.



February 28, 2017 – 1521 hours

A vehicle was stopped on State Route 725 after a routine registration check revealed that the driver did not have a valid driver's license. The 23-year old female suspect from Jamestown was cited into Xenia Municipal Court for two counts of Driving under Suspension and Failure to Reinstate License.

March 1, 2017 – 1022 hours

A burglary alarm activation was reported on Sable Ridge Drive. Upon the officers' arrival it was learned that the homeowner's daughter had accidentally activated the alarm.

March 2, 2017 – 2050 hours

An officer located a disabled vehicle on West Franklin Street while on routine patrol. The officer stood by and provided traffic control until no longer needed.

March 3, 2017 – 0056 hours

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation.

Investigation revealed that the 19-year old male from Dayton was impaired. Drugs were located inside the vehicle. The suspect was cited into Xenia Municipal Court for Operating a Vehicle while under the Influence, Drug Abuse, Possession of Drug Paraphernalia, and Tinted Windows. He was released to a friend.

An officer responded to South Lakeman Drive to assist the West Carrollton Police Department with locating a suspect of a hit/skip accident in their city. Negative contact.

A resident on South Main Street reported being harassed on Social Media and her phone by a person known to her. Officers continue to attempt contact with the suspect to order him to cease all communication with the complainant.
