April 23, 2017 - 0227 hours

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation. Investigation revealed that the 42-year old male driver from Waynesville was impaired. The suspect was cited into Xenia Municipal Court for Operating a Vehicle while under the Influence and Window Tint, and released to a friend.

April 23, 2017 – 1731 hours

An officer stopped a vehicle on South Main Street for an equipment violation. Investigation revealed that the 23-year old female driver from Lebanon did not have a valid driver's license. She was cited into Xenia Municipal Court for Driving under Suspension, Defective Muffler, and Seatbelt Required.

April 24, 2017 – 0031 hours

A vehicle was stopped on State Route 725. Investigation revealed that the 32-year male from Centerville was highly intoxicated. He was cited into Xenia Municipal Court for Operating a Vehicle while under the Influence.

April 24, 2017 – 1157 hours

Officers were dispatched to Upper Hillside Drive on a burglary alarm activation. Investigation revealed that the homeowner's relative had accidentally set off the alarm.

April 24, 2017 – 2249 hours

An officer was dispatched to a business on Wilmington Pike to assist the Sugarcreek Township Police Department with a burglary alarm activation. Investigation revealed a false alarm.



April 25, 2017 – 1210 hours

An officer located an unlicensed vehicle in the driveway of a residence on Maxwell Drive. The vehicle owner was given a 10-day warning to get proper registration for the vehicle or remove it from the property.

April 25, 2017 – 1241 hours

A vehicle owner on Portage Path Drive was issued a 10-way warning for having an unlicensed vehicle in his driveway.

April 26, 2017 - 0208 hours

An officer was dispatched to a business on Wilmington Pike to assist the Sugarcreek Township Police Department with a shoplifting complaint. The officer assisted with detaining several suspects and transporting them to their police department.

April 26, 2017 - 0432 hours

An officer was dispatched to the parking lot of a restaurant on Wilmington Pike in Sugarcreek Township on the report of a subject who was sleeping in his vehicle. Investigation revealed that the 23-year old male suspect from Waynesville was intoxicated. He was cited into Xenia Municipal Court for Physical Control of a Vehicle while under the Influence. He was released to a relative.

April 27, 2017 – 0250 hours

While on routine patrol an officer located an open garage door on Jacob Hills Court. Contact was made with the homeowner who checked the garage to assure that nothing was missing and then closed the door.

April 27, 2017 – 1411 hours

An assault was reported on West Maple Street. Investigation led to a 26-year old male being cited into Xenia Municipal Court for Assault and Disorderly Conduct by Fighting. A 25-year old



female from Lebanon who had displayed a knife during the assault was arrested and charged with Aggravated Menacing. She was transported to the Greene County Jail. The victim, a 31-year old male from Bellbrook was transported to the hospital. The victim was wanted on a warrant and after release from the hospital, transported to the Greene County Jail.

April 28, 2017 – 0303 hours

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation. Investigation revealed that the 25-year old male driver from Mason did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension and Defective Muffler.

April 28, 2017 – 1300 hours

A resident on Barnett Drive reported that she had responded to an e-mail which she believed had come from her bank, and given her personal and banking information out. Hours later she found that her bank account was overdrawn. A report was taken and the victim was given information about Identity Theft.

April 29, 2017 – 1044 hours

A business manager on State Route 725 reported receiving a scam phone call from a local utility company advising that she needed to pay the business' outstanding bill or the utilities would be shut off immediately. The business manager advised that she knew it was a scam because the account was up to date. The complainant did not send any money or gave out any personal information.

Two more reports were taken on Nedra Drive and at Bellbrook Plaza. The complainants of both reports advised they had received the same phone call.

April 29, 2017 – 1716 hours

Officers were dispatched to Cabernet Way on the report of a burglary alarm activation. Investigation revealed a false alarm.



April 29, 2017 – 2233 hours

Officers were dispatched to Mill Pond Drive on the report of loud music. Upon arrival, officers located several subjects inside the clubhouse playing loud music with the doors open. The doors were closed, correcting the problem. No further complaints were received.
