May 14, 2017 – 1253 hours

Officers were dispatched to West Franklin Street for a burglary alarm activation. A known subject in the building advised he had accidentally set off the alarm.

May 14, 2017 – 1330 hours

An officer was dispatched to Justin Court on a complaint of grass clippings on the sidewalk and in the street. Upon arrival the officer made contact with the responsible party who was advised of the City ordinance to keep yard debris from any sidewalk or roadway. The subject was cooperative and cleaned up the grass.

May 14, 2017 – 1355 hours

A traffic accident was reported on West Franklin Street near Little Sugarcreek Road. The driver at-fault, a 40-year old female from Dayton was cited into Xenia Municipal Court for Failure to Control.

May 17, 2017 – 0135 hours

An officer assisted the Sugarcreek Township Police Department with a suspicious occupied vehicle at Bellbrook High School. Contact with the occupant of the vehicle revealed that he had parked the vehicle and fallen asleep. No problem.



May 18, 2017 – 0234 hours

An officer stopped a vehicle for an equipment violation on Wilmington-Dayton Road. Investigation revealed that the 44-year old driver from Vandalia did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension.

May 18, 2017 – 0514 hours

An officer assisted the Sugarcreek Township Police Department with a Theft from a business on Wilmington Pike. The officer stood by for safety during the investigation into three suspects.

May 18, 2017 – 0521 hours

A burglary alarm was reported at a business on State Route 725 in Sugarcreek Township. An officer assisted the Sugarcreek Township Police Department and checked the business. There were no signs of criminal activity. False alarm.

May 18, 2017 – 1256 hours

A resident on Possum Run Road reported Identity Theft. The complainant advised that he had received numerous phone calls from collection agencies over the past few months, but does not know who charged these debts in his name. The complainant was given advice about his options and how to protect his identity in the future.

May 18, 2017 – 1514 hours

A resident on Moss Oak Trail reported that an unknown subject from Connecticut had fraudulently charged a number of purchases on his credit card. The bank was contacted and will not hold the victim responsible for the credit card charges. The complainant was given advice about protecting his identity in the future.



May 18, 2017 - 1730 hours

A traffic accident was reported on Upper Hillside Drive. The driver at-fault, a 26-year old male from Springfield had accidentally struck a parked vehicle while backing out of a driveway. The vehicle owners exchanged insurance information.

May 19, 2017 – 0330 hours

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation. Investigation revealed that the 17-year old driver from Waynesville was impaired. Marijuana was located inside the vehicle. The suspect was cited into Greene County Juvenile Court for Operating a Vehicle while under the Influence, Drug Abuse, a Probationary Driver's License Restrictions violation, and Tinted Windows.

May 19, 2017 – 1125 hours

A burglary alarm activation was reported on Woodacre Drive. Officers made contact with the homeowner who advised he had accidentally set off the alarm.

May 19, 2017 – 1320 hours

Officers provided traffic control and assistance to the Sugarcreek Township Police Department with a traffic accident on Wilmington-Dayton Road until no longer needed.

May 19, 2017 – 1952 hours

Officers were dispatched to Portage Path Drive on a domestic dispute in progress. Investigation revealed a verbal dispute had taken place. Officers were dispatched back to the same residence 2 hours later when one of the subjects was reportedly out of control and suspected of drug usage. A 36-year old female from Bellbrook was transported to the hospital to be evaluated.

May 19, 2017 – 2302 hours

An officer assisted the Centerville Police Department with a hit-skip accident investigation. The suspect who resides on Periwinkle Drive was cited into Montgomery County Court.



May 20, 2017 – 0027 hours

A loud party was reported on Shore Drive. The homeowner was advised of the complaint and told to keep it down. No further problems were reported.

May 20, 2017 – 1605 hours

A domestic dispute was reported where two brothers were fighting in the rear yard of a residence on Ridgeway Road. No physical altercation had taken place. Report taken.

May 20, 2017 – 2208 hours

Officers were dispatched to a business on State Route 725 on the report of an assault. The victim sustained serious injuries. The report is under investigation and criminal charges are pending.
