# June 25, 2017 - 0104 hours

A suspicious vehicle was reported parked in front of a business on State Route 725. Contact with the driver revealed that he was an Uber driver waiting for a customer.

# June 25, 2017 – 0109 hours

An officer assisted the Sugarcreek Township Police Department with an incident on Bayberry Cove Drive where two subjects had fled on foot after observing the Sugarcreek Township Police Officer. Officers checked the area but were unable to locate anyone.

# June 25, 2017 – 0235 hours

An officer stopped a vehicle on State Route 725 after a routine registration check revealed that the driver did not have a valid driver's license. The suspect, a 30-year old male from Dayton, was cited into Xenia Municipal Court for Driving under Suspension.

# June 25, 2017 – 0445 hours

While on routine patrol an officer located an open door at a business on State Route 725. Officers checked the building and found no signs of criminal activity. A key holder was contacted to re-secure the building.

While on routine patrol an officer observed a vehicle pass him and then abruptly stop on Possum Run Road. The male passenger got out of the vehicle and proceeded to the female driver and attempted to violently pull her from the vehicle. Investigation led to the 18-year old male from Bellbrook being cited into Xenia Municipal Court for Disorderly Conduct by Fighting or Turbulent Behavior. The 17-year old female driver from Farmersville was picked up by a parent.

An officer stopped a vehicle on Wilmington-Dayton Road for a vehicle registration violation. The owner of the vehicle, a 27-year old female passenger in the vehicle, was cited into Xenia Municipal Court for Expired Registration. Investigation revealed that the driver, a 25-year old female did not have a valid driver's license. She was also wanted on an active warrant from Riverside Police Department. The suspect was cited into Xenia Municipal Court for Driving under Suspension. She was arrested on the active warrant and custody was transferred to a Riverside Police Officer.
