#### July 11, 2017 2319 hours

Officers were dispatched to Springcreek Circle on a Domestic Dispute. Further investigation revealed that a sixteen year old juvenile was having verbal dispute with his mother about possibly moving out of state. With the mother's permission, the juvenile was about to stay with his grandparents for the night.
