December 10, 2017 – 0045 hours

A fight was reported at a business on State Route 725. Investigation led to multiple arrests. A 31-year old male from Dayton was charged with Disorderly Conduct by Fighting. He was transported to the Greene County Jail. A 45-year old male from Dayton was found in the possession of a drug scale, drug pipe, and suspected methamphetamine. That suspect was charged with two counts of Possession of Criminal Tools and felony charges pending. He was transported to the Greene County Jail. A 31-year old female from Bellbrook was found in possession of marijuana and drug needles. The female was charged with Possession of Drug Abuse Instruments and Drug Abuse. She was also transported to the Greene County Jail.

December 10, 2017 – 1517 hours

Officers assisted the Sugarcreek Township Police Department with the investigation of a Road Rage incident that had occurred in their jurisdiction. One of the suspects lives of Beryl Drive. The Bellbrook officers stood by while a Sugarcreek Township Police Officer interviewed the suspect.

December 11, 2017 – 2326 hours

A dispute was reported on Shadowood Circle. Investigation revealed that a verbal argument had taken place. The involved parties were separated.

December 12, 2017 – 0237 hours

An officer stopped a vehicle on Possum Run Road for a moving violation. Investigation revealed that the 27-year old male driver from Spring Valley was wanted on a warrant from the Warren County Sheriff's Department. The suspect was transported to the Waynesville Police Department where a Warren County Sheriff's Deputy picked up the suspect and transported him to the Warren County Jail.

December 12, 2017 – 1330 hours

Officers assisted the Sugarcreek Township Police Department on the report of Domestic Violence on Washington Mill Road. Officers stood by until no longer needed.



December 14, 2017 - 1444 hours

An officer observed a suspicious vehicle that had been parked on West Franklin Street near Petrikis Park for several hours. The officer made contact with the driver who told the officer he was tired and trying to sleep in his car before going to work.

December 14, 2017 – 2054 hours

An officer observed a vehicle on State Route 725 near Washington Mill Road that had failed to stop for Warren County Sheriff Deputies after involved in a traffic violation in Warren County. The driver also failed to stop for the Bellbrook Officer. Officers have identified the driver and the case was assigned to a detective. Charges are pending.

December 15, 2017 – 0935 hours

An officer made contact with a resident on Beechwood Drive who had a vehicle parked on private property without any license plates. The officer explained the violation to the vehicle owner, who advised that the vehicle was being towed from the property.

December 15, 2017 – 1450 hours

Officers responded to a business on State Route 725 on the report of an intoxicated subject. Witnesses had observed the subject driving a vehicle, striking several curbs and running off the roadway multiple times. Contact was made with the driver, a 38-year old female from Dayton. The female was impaired and did not have a valid driver's license. A baggie with a substance suspected to be methamphetamines was located in the female's sock. The suspect was taken into custody and charged with Operating a Vehicle while under the Influence and Driving under Suspension. Felony charges are pending. The suspect was transported to the Greene County Jail.

December 16, 2017 – 0100 hours

A female reported that she had been assaulted while at a business on State Route 725 three days earlier. The suspect, a 35-year old male from Bellbrook was cited into Xenia Municipal Court for Assault and Disorderly Conduct by Fighting.



December 16, 2017 - 0245 hours

An officer stopped a vehicle on Maxwell Drive for a moving violation. The driver, a 23-year old male from Bellbrook was impaired. The suspect was taken into custody and cited into Xenia Municipal Court for Operating a Vehicle while under the Influence and Failure to Stay in Marked Lanes.

December 16, 2017 – 1936 hours

A car traveling on West Franklin Street was struck by a vehicle that had failed to stop at the posted stop sign at the intersection of Regent Park Drive and West Franklin Street. The driver at-fault, a 76-year old female from Bellbrook, drove into the lane of travel of the other vehicle, striking it on the passenger side. The suspect was cited into Xenia Municipal Court for Failure to Obey a Traffic Control Device.
