## January 6, 2018 – 1951 hours

An officer was dispatched on the report of a hold-up alarm at a residence on Cabernet Way. Investigation revealed that the homeowner had accidentally set off the alarm.

#### **January 7, 2018 – 0915 hours**

Officers assisted the Bellbrook Fire Department with a residential fire on Viewpoint Drive. Traffic control was provided until no longer needed.

#### January 7, 2018 – 2059 hours

A domestic dispute was reported on Wilmington-Dayton Road. Investigation revealed a verbal argument had taken place. No charges filed.

# January 8, 2018 – 1449 hours

While on routine patrol an officer located a vehicle parked on the roadway with four flat tires. Contact was made with the vehicle owner who was told to have the vehicle removed from the public roadway within 10 days.

# January 9, 2018 – 1850 hours

An officer was dispatched to the parking lot of a business on West Franklin Street on the report of a suspicious vehicle. The officer located a 31-year old male from Bellbrook sleeping inside the vehicle. Contact was made and the subject advised he had just left work and was tired. The officer told him he could not sleep in the parking lot and to leave the area.

# January 9, 2018 – 1901 hours

A resident on Ridgeway Road reported that while watching the evening news, Crime Stoppers showed a stolen trailer that the Fostoria Police Department was trying to find. The resident reported that it matched a trailer that he had recently purchased in Lima and wanted to return it to its' rightful owner. After checking a partial VIN number and contact with the Fostoria Police Department it was confirmed this was the reported stolen trailer they had been looking for. The rightful owner from Fostoria picked up his trailer from Ridgeway Road.



#### January 9, 2018 – 2049 hours

A domestic dispute was reported on South Linda Drive. Investigation led to the arrest of a 17-year old male for Domestic Violence and Assault. The suspect was transported to the Greene County Juvenile Detention Center.

#### January 10, 2018 – 1807 hours

A resident on West Maple Street reported that someone had stolen a car jack and jack stands from his truck. Report taken. No suspect(s) at this time.

#### January 10, 2018 – 1936 hours

Officers responded to South Linda Drive to attempt to locate a subject wanted on a warrant from the Kettering Police Department. The 43-year old wanted female was located at her residence and taken into custody. She was turned over to a Kettering Police Officer.

# January 10, 2018 – 2340 hours

A routine vehicle registration check on Wilmington-Dayton Road revealed that the driver did not have a valid driver's license. The 32-year old driver from Spring Valley was cited into Xenia Municipal Court for Failure to Reinstate an Operator License.

# January 11, 2018 – 0302 hours

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation. Investigation revealed that the 25-year old male driver from Bellbrook did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension and a Vehicle Registration violation.

#### January 11, 2018 – 1308 hours

A resident on Tampico Trail reported telephone harassment. The suspect was located and ordered to cease all contact with the complainant.



## January 11, 2018 - 1717 hours

A resident on Sugarwood Circle reported a possible active domestic dispute on West Franklin Street. The complainant advised he heard intermittent screaming coming from a backyard. Contact was made at the residence in question, and investigation revealed that a small child was screaming in delight from riding a go-cart with her father. Officers cleared the scene.

#### January 11, 2018 – 1800 hours

A hit/skip accident was reported on South Main Street. The suspect driver cut in front of the accident driver, striking the vehicle on the left front quarter panel. The suspect driver then fled the scene. The report is under investigation.

#### January 11, 2018 – 1803 hours

An officer responded to the parking lot of a business on State Route 725 where a man had locked his keys in his vehicle. The officer was able to gain entry into the vehicle.

# January 12, 2018 – 1605 hours

A resident on Spring Creek Circle reported that her vehicle had been stolen. It was later learned that the vehicle owner had left her vehicle parked on private property for more than four months and the property owner had the vehicle towed in November. The complainant was referred to the tow lot to pick up her vehicle.
