April 8, 2018 - 0151 hours

An officer stopped a vehicle on Sugar Run Trail for a moving violation. Investigation revealed that the 39-year old male driver from Bellbrook was impaired. The subject was cited into Xenia Municipal Court for Operating a Vehicle while under the Influence and Lane of Travel upon Roadways.

April 8, 2018 – 1256 hours

A resident on Locus Bend Drive reported that tools had been stolen from his unlocked vehicle parked in front of his residence. Report is under investigation.

The suspect was cited into Xenia Municipal Court for Operating a Vehicle while under the Influence and Leaving the Scene of an Accident. The vehicle was towed due to extensive front end damage.

April 14, 2018 – 0038 hours

An officer located an unattended recreational fire on West Franklin Street. The Bellbrook Fire Department responded to extinguish the fire.

April 14, 2018 - 0325 hours

An officer stopped a vehicle on Little Sugarcreek Road for an equipment violation. The officer detected an odor of marijuana upon approaching the vehicle. A Police K9 from the Kettering Police Department assisted in the drug search. Marijuana and a drug pipe were located inside the vehicle. The 31-year old male driver from Bellbrook was cited into Xenia Municipal Court for Operating a Vehicle while under the Influence, Drug Abuse, Possession of Drug Paraphernalia, and Failure to Dim Headlights.
