### **June 4, 2018 – 1520 hours**

An officer stopped a vehicle on Poston Drive for a registration violation. Investigation revealed that the 35-year old male driver from Miamisburg did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension. He was given a warning for no visible registration on a vehicle.

### **June 4, 2018 – 1810 hours**

Officers were dispatched to Rosecrest Drive on a burglary alarm activation. Upon arrival officers learned that the homeowner had accidentally set off the alarm.
