July 22, 2018 - 1427 hours

An officer took a report of family members sending disturbing text messages. The primary suspect was contacted and told to refrain from contacting the complainants.

July 22, 2018 – 1846 hours

An unwanted subject was reported at a business on State Route 725. The subject had visited the business on several occasions had been loud and distracted employees. The manager requested that the 56-year old male from Dayton was removed from the business. The suspect was criminally trespassed from the property.

July 23, 2018 – 1750 hours

A domestic dispute was reported on North East Street. Investigation led to the arrest of a 37-year old female from Bellbrook for Domestic Violence and Assault. The suspect was transported to the Greene County Jail.
