July 29, 2018 – 0243 hours

An officer located a 12-year and 13-year old female walking on West Franklin Street. The females were transported to their homes. The parents were issued curfew violation warnings.

July 29, 2018 – 1210 hours

An officer stopped a vehicle on North Main Street for an equipment violation. Investigation revealed that the 61-year old male driver from Xenia did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension and issued a warning for Cracked Windshield.

July 29, 2018 – 1234 hours

Officers were dispatched to Vineyards Way on the report of a disorderly subject. Investigation led to an 18-year old female being cited into Xenia Municipal Court and criminally trespassed from the property.

July 31, 2018 – 0910 hours

An officer was dispatched to Birch Bark Court where a male from Mason had locked his keys in his vehicle. The officer was able to gain entry into the vehicle.



July 31, 2018 – 1353 hours

An accident was reported on North Main Street where a parked vehicle was struck, breaking a side mirror. The driver at-fault, a 23-year old male from Arcanum was cited into Xenia Municipal Court for Failure to Maintain Reasonable Control.

July 31, 2018 – 1713 hours

An officer stopped a vehicle on South Linda Drive after investigation revealed that the 46-year old male driver from Moraine did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension.

August 1, 2018 – 2306 hours

Officers assisted the Sugarcreek Township Police Department with a traffic accident on Wilmington-Dayton Road until no longer needed.

August 1, 2018 – 1623 hours

A traffic accident was reported on Wilmington-Dayton Road. A vehicle slowing down for traffic was struck on the rear bumper by the vehicle behind it. The driver at-fault, a 71-year old female from Waynesville was cited into Xenia Municipal Court for Failure to Maintain Assured Cleared Distance.

August 1, 2018 - 1747 hours

A resident on Kensington Drive reported that an unknown subject had opened a loan in his name in the amount of \$750.00. The complainant reported that he was not being held liable for the loan. The complainant was given information to protect himself from any future identity theft.

August 1, 2018 – 2209 hours

While on routine patrol an officer located an occupied suspicious vehicle on Vemco Drive.

August 2, 2018 – 1120 hours

Officers assisted the Northeastern University Police Department by contacting a resident on Kensington Drive and criminally trespassing him from their campus.

July 4, 2018 – 0210 hours

A dispute was reported on Wilmington-Dayton Road. Investigation revealed that it had been verbal in nature. The involved parties separated for the evening.

August 4, 2018 – 1147 hours

An officer responded to Upper Bellbrook Road on the report of a dog running loose in the area. Upon arrival the dog was located and it jumped into the officer's patrol car. The owner was determined by the canine's dog tag and contact was made. The owner arrived shortly thereafter to pick up the dog.

August 4, 2018 – 1439 hours

A 3-year old child was found wandering on Brookwood Drive. This was not the first time that the child from North East Street had walked away from her home by herself. A 61-year old relative who was babysitting the child was cited into Xenia Municipal Court for Child Endangerment.

August 4, 2018 – 1524 hours

An Upper Hillside Drive resident had locked himself out of his vehicle parked on North Main Street. An officer was able to gain entry into the vehicle.
