August 5, 2018 – 0042 hours

An officer stopped a vehicle on North Main Street for an equipment violation. Investigation revealed that the 26-year old male driver from Bellbrook did not have a valid driver's license. A 22-year old female passenger was wanted on a warrant from the Fairborn Police Department and placed under arrest. She was then transported and taken into custody by a Fairborn Police Officer.

August 5, 2018 – 1627 hours

A resident on Moss Oak Trail reported finding graffiti on the outside door and wall of a shed in her backyard. The lock had also been removed, and the door to the shed was found standing open. Nothing appeared to be stolen from the shed. No suspects at this time.

August 6, 2018 - 0058 hours

Officers assisted the Sugarcreek Township Police Department with a theft at a business on Wilmington Pike until no longer needed.

August 7, 2018 – 0800 hours

An officer was dispatched to Periwinkle Drive on a fraud report. The complainant advised that he had received a phone call from a person who claimed his computer had been hacked and to buy pre-paid gift cards in order to fix his computer. The complainant bought a total of \$500.00 in gift cards and provided the caller with the card account numbers. The report is under investigation.



August 7, 2018 – 1746 hours

An officer responded to Vineyards Way for the Miamisburg Police Department to make contact with a resident whose elderly father had been located in their City after being lost. Contact was made and the message was relayed.

August 8, 2018 – 0218 hours

A welfare check of a North Main Street was requested after the complainant was unable to make contact with her friend. Officers were able to make contact after several attempts. The subject had been asleep and had not heard her telephone.

August 10, 2018 - 0126 hours

An officer located two 13-year old females walking on Beryl Drive. Contact was made with the girls' parents and issued curfew violations warnings.

August 10, 2018 - 0654 hours

An officer assisted the Sugarcreek Township Police Department with a traffic accident in the parking lot of a business on Wilmington Pike. Report taken.

August 10, 2018 – 1159 hours

An officer stopped a vehicle on West Franklin Street after a routine registration check revealed that the driver did not have a valid driver's license. The suspect, a 27-year old male from Troy was cited into Xenia Municipal Court for Driving under Suspension.

August 11, 2018 – 1355 hours

An officer observed a male riding a bicycle with a small child on his back. The 3-year old girl was holding onto the subject by wrapping her arms around his neck. The officer ordered the male to stop, and put the girl who was not wearing a helmet safely on the ground. The subject initially refused but finally stopped at Bellbrock Park. The subject identified as the 23-year old



father was cited into Xenia Municipal Court for Child Endangerment. The 3-year old child was picked up by her mother.

August 11, 2018 – 2222 hours

While on routine patrol an officer located a vehicle at Magee Park after hours. Contact was made with the driver who advised she was playing the Pokemon Go game. The female was advised she could not be in the park at that time of day and left the area.
