**May 27, 2019 – 1333 hours**

Officers responded to Kensington Drive on a burglary alarm activation. The homeowner was notified and the residence checked secure.

**May 27, 2019 – 1535 hours**

A single car traffic accident was reported on East Franklin Street. A vehicle traveling Westbound on East Franklin Street swerved off the roadway and struck a tree head on. The driver, a 21-year old female from Urbana was found to be impaired. She was transported to the hospital and cited into Xenia Municipal Court for Operating a Vehicle while under the Influence, Failure to Control, and Seat Belt Required.

**May 28, 2019 – 1902 hours**

A disturbance was reported on Pinegrove Drive. The complainant advised that a friend had stolen some of his medication and also assaulted him. Consent to search the suspect's vehicle was received. No pills were located. The prosecutor's office declined any charges. The complainant requested the suspect to be removed from his property. The 24-year old female suspect from Centerville was criminally trespassed.

**May 28, 2019 – 2049 hours**

An officer was dispatched to South Lakeman Drive for a parking complaint. A large boat was parked on the roadway causing a traffic hazard. Contact was made with the owner who advised that she would resolve the problem.

**May 28, 2019 – 2214 hours**

A disturbance was reported on Pinegrove Drive. Investigation revealed two male subjects were involved in a physical fight. A 26-year old male from Centerville was cited into Xenia Municipal Court for Disorderly Conduct by fighting and given a criminal trespass warning. A 26-year old male from Bellbrook was also cited into Xenia Municipal Court for Disorderly Conduct by Fighting.



**May 30, 2019 – 1026 hours**

A resident on Eckworth Drive reported that he was contacted by PayPal and advised he owed them over \$900.00. The complainant advised he did not have a PayPal account nor make a purchase through them. An identity theft report was taken and forwarded to PayPal's Fraud Department.

**May 30, 2019 – 1413**

An officer assisted a 37-year old female from Bellbrook who had locked her keys in her car at Bellbrook Plaza. The officer was able to gain entry into the vehicle.

**May 30, 2019 – 1452 hours**

A resident on East South Street reported that his neighbor, a 15-year old juvenile had showed up at his home complaining of a head injury. The juvenile had been home alone stumbled into a wall. Bellbrook Medics responded and the child was transported to the hospital where he was met by a parent.

**May 31, 2019 – 1346 hours**

Officers responded to Beechwood Drive for a possible residential fire. Upon arrival smoke was seen coming from the residence but there was no fire. The resident had forgotten about food she was cooking and had left on her stove. The Bellbrook Fire Department assisted with airing out the residence.

**May 31, 2019 – 1707 hours**

A minor private property crash was reported in the parking lot of a business on West Franklin Street. The involved parties exchanged insurance information.



### **May 31, 2019 – 2036 hours**

An officer stopped a vehicle on Wilmington-Dayton Road for a registration violation. Investigation revealed that the 45-year old male driver from Vandalia did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension, and Failure to File for Annual Registration.

### **June 1, 2019 – 1217 hours**

A domestic dispute was reported on Sudbury Court. Contact was made with a 25-year old male who advised he had been in an argument with his girlfriend and when she was leaving in her vehicle, he had hit the windshield causing it to shatter. The female had left the scene but was located in the parking lot of a business on Wilmington Pike. The suspect advised he would pay for the damage to the windshield. No other threats, or physical violence had taken place. Report taken.

### **June 1, 2019 – 2312 hours**

An officer stopped a vehicle on West Franklin Street for an equipment and moving violation. Investigation revealed that the 26-year old male driver from Dayton did not have a valid driver's license. The suspect was cited into Xenia Municipal Court for Driving under Suspension, Failure to File for Annual Registration, and given a warning for Improper Turn.
