July 16, 2019 – 1144 hours

Officers checked the area of Linda Dr on a report of a subject riding a bike in the area. The subject was picked up by a truck pulling a trailer. The subjects were not located.

July 16, 2019 – 1231hours

Officers responded to W. Franklin Dr on a report of a Domestic. The dispute was between the resident and her 17 year old great granddaughter. The dispute was verbal only.

July 16, 2019 – 1348 hours

Officers responded to S. Main St on a report of old payroll checks being used fraudulently. Investigation into these checks and gaining additional information is ongoing.

July 16, 2019 – 2209 hours

An open door was reported on S. East St. The building was secured and owner notified.

July 16, 2019 – 2224 hours

Officers responded to Dot's parking lot to check on a driver parked in the lot. The driver was checked and was ok. Driver left the area without incident.

July 717, 2019 – 1144hours

Officers attempted contact with a resident on Hillrise Cir. To advise a piece of property was located. The homeowner was not home.

July 18, 2019 – 1417 hours

Officers responded to Bellemeade Dr on an animal complaint. Upon officers arrival, officers assisted the animal and freed it from its confines.



July 18, 2019 – 2128 hours

Officers responded to Tampico Trl. on a report of an alarm. Officers checked the exterior of the building and all was secure.

July 18, 2019 – 2238 hours

While on bike patrol, a bike officer found an open door to a business next to Dot's. Officers entered the building and found everything to be in place. A keyholder was advised, and the officers locked the building.

July 19, 2019 – 0800 hours

Units responded to an alarm on Knob Hill. Upon arrival, units met with the resident who advised he had set the alarm off accidentally.

July 19, 2019 - 1414 hours

Units responded to Mill Pond apartments on a welfare check. The resident's employer was concerned since he did not arrive for work. Upon PD unit's arrival there was no answer at the door. Apartment management allowed us entry to check on the occupant. It was discovered he had died. The appropriate contacts to his personal Dr, the Coroner's Office and next of kin were made. Investigation is ongoing.
