September 1, 2019 – 0017 hours

An officer was dispatched to Regent Park Drive on the report of a suspicious person walking towards West Franklin Street with several bags. The officer located the subject, who advised she was walking to the bus stop after having been in a verbal altercation with her mother. The female was given a ride to the bus stop.

September 1, 2019 – 0124 hours

An officer stopped a vehicle on Wilmington-Dayton Road for an equipment violation. Upon contact with three occupants in the vehicle, the officer could smell a strong odor of marijuana coming from the vehicle. The juvenile driver and one passenger were found to be in possession of vaping devices which were confiscated. A 16-year old male passenger from Bellbrook was charged with Drug Abuse and Possession of Marijuana. The 16-year old driver from Bellbrook was cited into Greene County Juvenile Court for No License Plate Light. All juveniles were found in violation of the curfew law and contact was made with their parents.

September 1, 2019 – 1445 hours

A debit card was left in an ATM machine at a bank on West Franklin Street. The owner was located and the property was returned to him.

September 1, 2019 – 1552 hours

An officer assisted the Sugarcreek Township Police Department with a report of juveniles with a weapon at Ron Kehl Park. Investigation revealed the weapon was actually a lighter, modeled after a revolver. The officer stood by until no longer needed.

September 2, 2019 – 0102 hours

An officer was dispatched to Sugarwood Circle on a loud music complaint. The officer located the source of the music and made contact with the resident. The resident was advised of the complaint and turned off the music.



September 2, 2019 – 1008 hours

A found bank card was turned into the police department. The owner was located and an officer returned the property to the Sugarcreek Township resident.

September 3, 2019 – 0626 hours

An officer was requested to perform a welfare check on a male subject who was sleeping in a vehicle on Hillcrest Drive. Contact was made with the driver who advised he was waiting for his crew members to arrive to complete road construction.

September 3, 2019 – 1109 hours

A welfare check was requested on a resident on Bledsoe Drive after her employer had not been able to make contact with her. Contact was made and the female was ok. She was advised to contact her employer.

September 3, 2019 – 1257 hours

A parking problem was reported on North East Street where a vehicle was parked in a no parking zone and halfway on the sidewalk. Neighbors did not know where the vehicle owner was. The vehicle had been moved after the officer checked later in the day.

Officers responded to Upper Bellbrook Road on the report of an altercation. Investigation revealed a family dispute occurred. The involved parties separated ways. Report taken.

September 4, 2019 – 0051 hours

Loud music was reported on North Regent Park Drive. Upon arrival an officer located the source and made contact with the homeowner. The resident was advised of the complaint and turned off the music.



September 6, 2019 – 0845 hours

A resident on Poston Drive reported that someone had broken into his locked toolbox on his truck. Several tools were missing. There are no known suspects at this time. Report taken.

September 6, 2019 – 1330 hours

An officer responded to Tareyton Drive on a burglary alarm activation. Investigation revealed a relative of the homeowner had accidentally set off the alarm.

September 7, 2019 – 1420 hours

A traffic accident was reported on South Main Street. A vehicle attempting to make a U-turn did not have enough clearance to make the turn. The vehicle backed up and struck a telephone pole. The driver at-fault was cited into Xenia Municipal Court for Improper Backing.

September 7, 2019 – 1500 hours

A resident on Kensington Drive reported that her home had been broken into and jewelry was missing. A side door the residence had been unlocked prior to the break-in. The report is under investigation.

September 7, 2019 – 1616 hours

A business on State Route 725 reported that there was a small child in their store by himself. The Sugarcreek Township Police Department assisted with finding the child's home as the boy could not tell officers where he lived. Eventually he was returned to his home on Mill Pond Drive and contact was made with his 12-year old sister who was babysitting while the parent was at work. The parent was called to respond to the home and issued a warning for Child Endangerment.
